SECTION 7: Handling and Storage

Precautions for Safe Handling:

The primary hazard of sodium silicate is high alkalinity. Avoid release to the environment.

Appropriate Engineering Controls:

Emergency eye wash stations and safety showers should be available in the immediate vicinity of use or handling. Provide adequate ventilation to maintain the airborne concentrations of vapor, mists, and/or dusts below the applicable workplace exposure limits, while observing recognized national safety standards.

Appropriate Personal Protection Equipment (PPE)

Safety Glasses with Side Shields or Goggles

Use safety glasses with side shields or goggles. Consider the use of a face shield for splash protection. Use eye protection equipment that has been tested and approved by recognized national standards (or equivalent).

Gloves, Skin and Body Protection:

Protect the body and skin by wearing impervious gloves and clothing approved by the national safety standards. Gloves should be inspected prior to use. Appropriate techniques should be used to remove used gloves or contaminated clothing to prevent direct contact. If direct contact occurs, wash with soap and water.

Dust Mast/Respirator

Use a NIOSH-approved dust or mist respirator where spray mist occurs. Observe OSHA regulation for respirator use (29 CFR section 1910.134)
